ACTION: David will follow up with Darla to let her know the group is interested, and better assess what topics she is prepared to speak on.

<u>Advocacy with policy makers in Sacramento-</u> It was acknowledged that things have changed with CCLT now that Darla is no longer spending time on advocacy and this may be an area where the NRC wants to pull together to be sure legislative issues are being monitored and the region is in a position to respond as needed.

<u>Collection of data on trends in the region</u> that would help inform land managers. Galen elaborated on this area that he mentioned during our last call. He felt it would be helpful for folks to share knowledge about trends in land values, how different economic factors are affecting land trusts (ie contractors and steel in the wake of the fires, impacts on land values with the volatile cannabis industry, timber values, etc...). Perhaps there could be a committee formed that would follow these issues and report on current trends.

ACTION: Those planning on attending the CCLT conference (Bob, Beth, Kerri, Tom, April, & Sandy) will keep their ears open to the issues of advocacy and land trends at the conference and report out at the next meeting scheduled for March 27th at 2pm
