What the Control, Regulate and Tax Adult Use of Marijuana Act means to Northern Region Land Trusts.

The California Council of Land Trusts has supports "Control, Regulate and Tax Adult Use of Marijuana Act" (AUMA) proposed for the November 2016 state ballot as the measure with strong environmental protections and the means of enforcement and remediation of damages to California's natural resources.

The passage of this Act has implications for Land Trusts working to restore, enhance and conserve lands impacted by marijuana cultivation. Join other Northern Region Council Members on a conference call, August 23 at 10am, with CCLT Executive Director Darla Guenzler to find out what the passage of this Act this means to your land trust how to play a part in implementing stronger environmental protections for impacted lands. If approved by voters, the Control, Regulate and Tax Adult Use of Marijuana Act (AUMA) assures that cultivation must comply with existing environmental laws in all areas of the state, and agencies can impose additional requirements to address the adverse impacts of cultivation on natural resources. Agencies must develop protocols for permitting and enforcing environmental protections. An excise tax will be divided among a number of public uses, with slightly less than one-fifth of the funds to be used for environmental purposes by the CA Department of Fish and Wildlife (CDFW) and CA State Parks and Recreation to clean-up and remediate the impacts of marijuana cultivation on natural resources, discourage and prevent illegal cultivation on public lands, and for enforcement by CDFW and a multi-agency task force.

June Humboldt County Trails Summit a Success!

Over 200 people packed the Wharfinger Building on June 4, for the first Trails Summit, designed to energize and engage the community in expanding a regional trails system. Hank Seeman, Deputy Director Environmental Services, Humboldt County Public Works Department shared the State of the Trails report and other city county and nonprofits were represented, including the Northern Region Council and Trinidad Land Trust.

Sonoma Land Trust finalizing deal to add land to Hood Mountain Regional Park

Sonoma County parks officials and county land acquisition

partners are finalizing a deal this month that will add an additional

162 acres to Hood Mountain Regional Park and Open Space Preserve, unlocking for the first time a privately owned and largely untouched wilderness in the Mayacamas Mountains to public access.

The \$319,000 deal for the private property by Sonoma Land Trust, a Santa Rosa-based nonprofit that acquires land to preserve it as open space, will allow Sonoma County Regional Parks to expand its network of hiking trails and overnight camping destinations, as well as protect a slice of highly coveted wildlands between Hood Mountain and Sugarloaf

THE MCKINLEYVILLE LAND TRUST

The McKinleyville Land Trust, working with Redwood Community Action Agency and the California Conservation Corps, is nearing completion of a new trail at Chah-GAH-Cho in McKinleyville. Chah-GAH-Cho is located behind the Mill Creek Shopping Center at the end of Betty Court off School Road. The new trail provides nearly three-quarters of a mile of crushed shale walking path that traverses through both grassland and forest canopy. A large portion of the trail is ADA accessible and



provides access to a beautiful overlook of the lower Mad River and coastline. The Land Trust expects the trail and amenities such as a kiosk and interpretive signage to be complete by September. In the meantime, people are welcome to visit and enjoy the changes at Chah-GAH-Cho!
